

This document states the materials and additives, where appropriate, that are used in the manufacture of Eco Ezee Ltd's decorating sundry products. It also covers other aspects such as sustainability practices, humane treatment of animals, where relevant, working conditions etc.

1. Pulp paint trays and paint kettles:

These products are made from 100% recycled cardboard and paper. After pressing, the products are dried using natural heat from the Sun, whenever possible. The water during manufacturing is recycled, filtered and re-used. Any products that are not formed correctly and recycled into subsequent pulp mixes.

The waterproofing agent that is used is called Alkyl Ketene Dimer (AKD) please find a data sheet attached at annex 1. This is a virtually non-toxic additive, which contains no harmful components.

2. Paint Brushes:

The handles are made from bamboo. Bamboo is a grass not a wood, it absorbs more carbon dioxide than a fully established stands of trees and emits 35% more oxygen. We only use bamboo from managed plantations; the rest of the criteria we apply are at annex 2. We have attached an information sheet at annex 3.

The stainless steel ferrules are made from recycled metal that is bought from metal recycling companies in main land China.

The bristles comprise both natural hog hair (Chungking) and synthetic material.

The hog hair is a bi-product of another manufacturing process...hog rearing for food processing. The animals, from which the hog hair comes, live in the Sichuan Province in China. The animals are treated in accordance with best rearing practice, are well cared for and are humanely slaughtered. The Hog in China is a very well respected animal as it is vital to the welfare of the Chinese people and is part of their staple diet.

The synthetic elements are made from recycled material namely polyester. They are solid round tapered, tipped and flagged.

Where feasible the paintbrush keepers and packaging is made from recycled card and paper using natural raffia to tie the paintbrushes on in the paintbrush packs. No metal clips, 'Velcro' or plastic is used in any of the brush packaging.

Roller Frames:

The roller frame handles are made from bamboo, the details of which are the same as those described in No 2 above.

The metal frame is made from recycled metal as described in No 2 above regarding the ferrules.

The plastic 'end caps' on the roller frame are made from recycled plastic, which is Polypropylene (PP).

4. Roller Sleeves:

The core of the roller sleeves are made from recycled plastic this is Polypropylene (PP).

The Nap is made from recycled polyester.

The outer plastic sleeve that contains the roller sleeve is made from starch and is biodegradable.

5. Dust Sheets:

The dustsheets are made from virgin Polyethylene (PE); it contains a special additive called 'Reverte' which is produced by a leading British company called Wells plastic. A data and fact sheet explaining this additive is at annex 4. The sleeve that contains the dustsheet also contains this same additive.

6. Working Conditions, Codes of Practice and Quality Assurance

We work in partnership with a large USA company who has been trading with Far Eastern countries for over 35 years. Any and all factories producing products for either them or us must conform to set international standards for their work force. These standards are audited regularly by their own inspection teams or by third party companies specialising in compliance and social audits. They assure us that all of the companies that they deal with do the following:

- a. Do NOT employ child labour
- b. Pay fair and reasonable wages
- c. Provide safe working conditions for all their staff
- d. Use sustainable processes within their companies where feasible

Consider the environmental impact on their processes.
